“Atlanta Braves A-Lister for a Day Giveaway” Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. **Eligibility:** The Giveaway is open to the members of the general public who are residents of Georgia and at least 21 years old as of the date of entry. Employees, directors, officers, and agents of Dickey Broadcasting Company, d/b/a WCNN-AM, Atlanta Braves, (WCNN-AM and Atlanta Braves collectively referred to as "Sponsor"), and their respective affiliates and the immediate families and household members of such persons are not eligible.
2. Void where prohibited by law. By entering this Giveaway, you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

Every weekday (Monday through Friday) from Monday, March 6, 2017 to Friday, March 24, 2017, each show will randomly select a different name from all entries to announce on-air. Individuals must listen to 680 The Fan or 93.7 FM in order to hear if their name is called. If their name is called, then he/she will have 15 minutes to call (404) 231-1680 to qualify to win the Grand Prize. If individual does not call within 15 minutes of hearing his/her name, then there will not be a qualifier from that hour of the day. There may be a total of four (4) qualifiers per day and a maximum of sixty (60) qualifiers total during the Promotional Period. Each qualifier will receive two (2) tickets to Atlanta Braves vs. New York Yankees game on Friday, March 31, 2017 at SunTrust Park. The Grand Prize winner will be randomly selected from all eligible qualifiers on Monday, March 27, 2017 and will be notified via phone and/or email.
5. Odds of winning depend on the total number of eligible entries.
