**“Primo Ceramic Grills Labor Day Sweepstakes” Official Rules**

*NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.*

1. **Eligibility:** The Sweepstakes is open to the members of the general public who are residents of Georgia and at least 21 years old as of the date of entry.
