

**Kia Soul Hero Giveaway**  
**OFFICIAL RULES AND REGULATIONS**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE CHANCES OF WINNING.**

**ELIGIBILITY:** In order to participate in the “Kia Soul Hero Giveaway” (herein referred to as the "Giveaway"), you must nominate an active or honorably discharged member of the United States Military or United States Coast Guard that resides in the state of Georgia, and who is twenty-one (21) years of age or older as of date of nomination, and possesses a valid Georgia driver’s license (here in referred to as “Eligible Nominee”) and follow the application process as outlined at [680thefan.com/kiahero](http://680thefan.com/kiahero). Officers, directors, representatives and employees of Dickey Broadcasting Company, d/b/a WCNN-AM and Atlanta West Kia (WCNN-AM and Atlanta West Kia collectively referred to as "Sponsor"), and any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, subsidiaries, participating retailers, advertising / promotion / judging agencies, persons engaged in the development, production or distribution of materials for this Giveaway (collectively, the “Released Parties”) and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, - whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Giveaway. This Giveaway is subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator's decisions, which are final and binding in all matters related to the Giveaway. Winning a prize is contingent upon fulfilling all requirements set forth herein. **Void where prohibited, taxed or restricted by law.**

**HOW TO ENTER:** Nominations will be accepted from 12:00 a.m. Eastern Time (ET) on Monday, May 28, 2018 to 11:59 p.m. ET on Wednesday July 18, 2018 (otherwise known as the "Entry Period"). Participants may nominate an Eligible Nominee online during the Entry Period by visiting the “Kia Soul Hero Giveaway” landing webpage at [680thefan.com/kiahero](http://680thefan.com/kiahero) by following the prompts and fully completing the online entry form. To enter the Giveaway, participants will need to provide: full name, age, home address, zip code, e-mail address and daytime phone number (with area code), Eligible Nominee’s name, address, and date of birth and an explanation, in 500 words or less, of why said Eligible Nominee deserves the Kia Soul. Eligible Nominees do not have to give permission in advance to be nominated for the Giveaway as they have the right to participate. All nominations must be received by the Sponsor no later than 11:59 p.m. ET on Wednesday, July 18, 2018. The official clock for the Giveaway is the computer of the Sponsor.

Limit of one (1) entry per person regardless of method of entry. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Sponsor is not responsible for misdirected, late, incomplete, illegible, undelivered, or lost entries, which will be disqualified, or any unforeseen circumstances that may limit an individual's ability to participate in the Giveaway. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant that submits more than the stated maximum limit of entries by using multiple/different addresses, identities, or any other methods, or who Sponsor believes has attempted to tamper with, influence or impair the administration, security, fairness, or proper play of this Giveaway. All entries become the property of the Sponsor and will not be acknowledged or returned.

**GRAND PRIZE QUALIFIER SELECTION:** From Monday, June 4, 2018 to Friday, July 20, 2018, Sponsor will select one (1) Eligible Nominee per week, for a total of seven (7) weeks, as a Grand Prize Qualifier (otherwise known as a “Qualifier”). There will be a maximum of seven (7) Qualifiers during the Entry Period. The odds of being selected as a Qualifier depend upon the total number of eligible entries received. Multiple, identical or duplicate entries for the same Eligible Nominee do not increase odds of being selected as judges are looking for compelling stories that indicate why an Eligible Nominee deserves the Kia Soul. Qualifiers will be determined by a judging committee appointed by Sponsor, and the decisions of the judging committee will be final. The judging committee will review nominations each week during the Entry Period starting the week of Monday, June 4, 2018. One (1) Qualifier will be selected and announced on The Sports X every Friday during the Entry Period and will be notified by phone and/or email. Each Qualifier will be required to provide military identification with either a Leave & Earnings Statement or a DD214 form to Sponsor within three (3) days after notification. Non-compliance with any requirement or obligation may result in disqualification and selection of an alternate Qualifier. Sponsor reserves the right to verify identification and eligibility of potential Qualifier before a prize will be awarded.

**GRAND PRIZE RECIPIENT SELECTION:** There will be one (1) Grand Prize Recipient. The odds of winning the Grand Prize are one in seven. All Qualifiers will be invited to Atlanta West Kia on Saturday, July 28, 2018 at TBD time for the Kia Soul Hero Giveaway Celebration where the Grand Prize Recipient (otherwise known as the "Prize Recipient") will be determined. After registering and signing the participation release, all seven (7) Qualifiers will randomly select a vehicle key labeled one (1) through seven (7). In order of vehicle key numbers, each Qualifier will have the chance to test their key on the Kia Soul until the correct key is found. The Qualifier whose key starts the engine will be deemed the Prize Recipient. The Prize Recipient will be required to sign an Affidavit of Eligibility and Release of Liability and must possess a valid Georgia driver's license and auto insurance card in order to take possession of the Grand Prize. These forms must be signed and received by Sponsor within fourteen (14) days after notification. Non-compliance with any requirement or obligation may result in disqualification and selection of an alternate Recipient. Sponsor reserves the right to verify identification and eligibility of potential Prize Recipient before a prize will be awarded.

**PRIZES:** One (1) Grand Prize will be available to be awarded. The Prize Recipient will receive a 2018 Kia Soul from Atlanta West Kia. **The Approximate Retail Value ("ARV") of the Grand Prize is TBD.** All awards go to the Prize Recipient, not to the individual(s) who nominated them.

All prizes to be awarded are not transferable and cannot be redeemed for cash. The Prize Recipient is responsible for the reporting and payment of all federal, state and local taxes (if any). Any portion of the Grand Prize not accepted by the Prize Recipient will be forfeited. The Prize Recipient will be issued a tax form 1099 for the ARV of the Grand Prize (as they are valued at \$600 or more). Sponsor reserves the right at its sole discretion to substitute any prize (or prize component) with another prize (or prize component) of equal or greater value. There are no substitutions unless specified by the Sponsor. The Sponsor and Released Parties are not in any way responsible or liable for damages, costs,

or expenses of any kind resulting from shipping and handling, loss, cancellation, delay, rescheduling, postponement, use or misuse of any prize awarded in this Giveaway.
